

Tables and Graphs

This part was drawn up on the basis of statistical data of the Police of the Czech Republic, unless otherwise noted. Detected crimes are identical with the number of criminal offences recorded by the Police of the Czech Republic in the given year. Crimes per 10 000 inhabitants is calculated in relation to the number of inhabitants on 1 January of the relevant year. The term “offender” is understood to mean known (detected) offenders of solved crimes.

NOTES ON THE TABLES AND GRAPHS SECTION

ACT NO. 40/2009 COLL. (CRIMINAL CODE) AND ITS EFFECTS ON CRIME STATISTICS

As of 1 January 2010, Act No. 40/2009 Coll., Criminal Code, came into force, bringing a number of changes to the field of criminal law, which are also reflected in criminal statistics.

The Criminal Code introduced 43 new crimes and a considerable number of sections was amended. The statistically important act of driving a vehicle without a driving license (Sec. 180(d) of Act No. 140/1961 Coll.), which was criminalised by an amendment in 2007, is no longer a criminal offence.

The very definition of crimes has changed. The physical concept of crimes has been abandoned, and its so-called social dangerousness is no longer assessed. The Criminal Code prefers a formal definition of crimes. It defines a crime as an illegal act, which is designated as such by the law and which shows the characteristics given by the law (the formal aspect). This fundamental change is, however, corrected by the so-called material correction, which stipulates that the criminal responsibility of an offender and the criminal consequences associated with it can be applied only in cases of socially harmful acts.

Another change is the introduction of a division of crimes into misdemeanours and crimes. The Criminal Code defines misdemeanours as negligent crimes and those crimes where the maximum punishment stipulated by the law is 5 years of imprisonment. Crimes are all crimes that are not misdemeanours according to the law.

Overall crime before and after the entry into force of the new Criminal Code cannot therefore be efficiently compared. A continuous comparison of criminal statistics in all their scope would not be feasible, as two variables would have been pitted against each other. In graphics, the change can be highlighted.

We believe that there is an extensive set of conditionally comparable subsets of crimes – and therefore categories of the tactical-statistical classification ESSK – which the changes (taking into account the corrective of socially harmful acts) introduced into practice by Act No. 40/2009 Coll. as of 1 January 2010 Sb. have left virtually unaffected. The conditional comparison of these data before and after the entry into force of the Criminal Code is, in our opinion, legitimate.¹

We recommend complementing and refining the information from annual situation reports in the field of internal security and public order in the Czech Republic with scientifically erudite findings and conclusions from criminological, victimological, and other researches, as well as detailed analyses with a longer periodicity, which are elaborated in cooperation with researchers and academicians or within their respective fields.²





in the Czech Republic from 2005 to 2014**




















**Development in the Number of Crimes of Bribery









2) No one was hurt or killed.


3) There was no damage caused to the property of other subjects - the road, buildings, traffic signs, etc.



Year to Year Changes in the Key Indicators Related to Traffic Accidents in the CR [in %] in 2014 as opposed to 2013



of Total Crime in the Czech Republic in 2013**



Shares of Individual Regions (higher territorial self-governing units) of Violent Crime in the Czech Republic in 2014




