Established in 1951, IOM is the leading inter-governmental organization in the field of migration and works closely with governmental, intergovernmental and non-governmental partners. With 172 member states, a further 8 states holding observer status and offices in over 100 countries, IOM is dedicated to promoting humane and orderly migration for the benefit of all. It does so by providing services and advice to governments and migrants.

IOM operates from the outset that trafficking in persons needs to be approached within the overall context of managing migration. Our broad range of activities is implemented in partnership with governmental institutions, NGOs and international organizations. IOM has been working to counter the trafficking in persons since 1994. IOM offers comprehensive direct assistance packages to victims of trafficking in collaboration with our partners. This includes accommodation in places of safety, medical and psychosocial support, skills development and vocational training, reintegration assistance, and the options of voluntary, safe and dignified return to countries of origin, integration in the country of destination or resettlement to third countries when needed.

These services include advice and information about voluntary return; contacting family in the country of origin; assistance in obtaining a travel document and travel arrangements, including flight ticket and airport assistance. Besides, IOM can provide specialized assistance to victims of trafficking after their return, depending on the individual needs. This includes, but is not limited to, accommodation, psychological, medical and reintegration support. Depending on the country of return, this assistance is provided directly by IOM or IOM will refer to partner organizations in the country of origin. In addition, in most
