**INFORMACE č. 2/2026**

**Korea – elektronická doložka Apostille**

Ministerstvo vnitra obdrželo nótu Velvyslanectví Korejské republiky v České republice ve věci vydávání elektronických apostilních doložek (dále jen e-apostila).


Z uvedené nóty vyplývá, že od 30. listopadu 2016 poskytuje vláda Korejské republiky prostřednictvím svých oficiálních webových stránek <https://apostille.go.kr> službu e-apostily, která umožňuje okamžité vystavení elektronické doložky online formou. E-apostily vystavené prostřednictvím této platformy mají stejnou právní účinnost jako apostily vydané v analogové podobě v souladu s Haagskou úmluvou o zrušení požadavku ověřování cizích veřejných listin ze dne 5. října 1961.

Postup pro ověření platnosti a pravosti dokumentu, jakož i e-apostily je následující.

- 1) E-apostila obsahuje ověřovací číslo (No.), které slouží ke kontrole pravosti a dále číslo vydání dokumentu (Issued No.), které zajišťuje jednoznačné propojení mezi e-apostilou a ověřovaným dokumentem (viz zobrazení níže).
