Motivation:

Why I selected DG EAC:

If selected for the NEPT programme, I would like to be assigned to DG EAC. More specifically, we cooperate closely with Unit B.1 – Higher Education, led by Ms Suzanne Conze on several priority topics, including but not limited to European Strategy for Universities, automatic recognition of qualifications, European Degree, or quality assurance. I am currently collaborating with other Member States and the Commission on several of these topics. Alternatively, I would like to work with DG EAC directorate B adviser on synergies between Research and Higher Education, Mr Giorgio Sonnino.

Current Responsibilities:

Firstly, I currently coordinate the Czech ENIC-NARIC centre and act as the national authority for academic recognition of foreign qualifications. In this capacity, I regularly represent the Czech Republic in the ENIC/NARIC network, negotiate at annual meetings, and contribute to shaping discussions on system-level recognition, automatic recognition, and the alignment with frameworks such as EQF and QF-EHEA. These processes are directly linked to DG EAC's priorities of deepening the European Education Area and facilitating cross-border learning.

Secondly, I manage the Student Mode programme, a strategic national scheme jointly co-ordinated by the Ministry of Education, Youth and Sports, Ministry of Interior and Ministry of Foreign Affairs, designed to streamline study-related migration from third countries. Each year, thousands of international students benefit from this scheme, which harmonises the work of universities, ministries, and consulates. Beyond admission, I also oversee follow-up phases: monitoring enrolments, study progression, and retention of graduates on the Czech labour market. Our recent analysis (2023, with the Ministry of the Interior) mapped study outcomes of admitted students, and since 2024 universities are obliged to provide structured reports on their performance. This makes Student Mode one of the most sophisticated policy tools for internationalisation in Czech higher education. Outcomes of the Student Mode strongly resonate with European debates on talent attraction, demographic renewal, and integration of international graduates into host economies, thus helping Czech Higher Education sector to develop in line with European Strategy for Universities and the Union of Skills.

Thirdly, I represented the Ministry of Education, Youth and Sports in the International Evaluation Panel of the Jan Evangelista Purkyně University, and the topic of finding synergies between Higher Education and Research has been intensively discussed by international experts in the panel. Based on the results of this evaluation process at all public and selected private universities, this topic has a potential to become a priority for the Ministry of Education, Youth and Sports in the near future.

How may the Commission and the Ministry of Education, Youth and Sports benefit from my secondment:

A traineeship at DG EAC would allow me to build on existing collaboration with the Commission and the Member States. If assigned to DG EAC B.1, I would bring practical insights into recognition procedures and student mobility management, while gaining first-hand experience of DG EAC's strategic policy making. If there is the opportunity to work with the department B Advisor on synergies between Research and Higher Education, I would make use of my knowledge of the research evaluation process in M3-M5 at public universities, and the insights on synergies presented by international experts in evaluation panels. After the traineeship, I would act as a multiplier, transferring European best practices to my colleagues at the Department of Higher Education, and broader spectrum of Czech stakeholders. To sum up, I would like to contribute to continuing development of Czech Higher Education Sector in line with the principles of the European Higher Education Area.
